- Many projects of the SPACE theme are finishing their 2nd project year
- The evaluation of the last SPACE call is finished results are not publicly available yet
- The Council recently agreed on a budget for HOR2020 the new framework programme for research and innovation the budget still needs to be approved by the Parliament
- Therefore the situation for the SPACE theme remains to be finalised: the topics, rules and areas of funding there will be a larger concentration on innovations/applications
- The next SPACE call will be published in Dec. 2014 (maybe earlier).

- **D4.3**: Clarify use of alerts by UGOE. Several activities on-going, not exclusively within AFFECTS
- **D2.2 and D2.7**: Alternative work to be proposed because SEPS is not going to fly -> include alternatives in Del. Report
- General overview on how tasks are progressing and WPs collaborate

 - REA wants to receive an overview on resources spent so far to detect over- or under-spending
- An app covering all partners shall be developed. Possibilities are shown with the help of
 existing apps (e. g. 3D Sun, Sun Viewer, The Sun Today, i3DSun, Solar Monitor, several
 RSS feeds, Embrace Space). App needs to be user-friendly (easy handling, reduced
 complexity) and innovative; definition of user is mandatory.

- Layout of a **product sustainability plan** is necessary. What happens with the products/services after the end of AFFECTS? First ideas from EVERY partner shall be integrated into the periodic report.
